To Whom It May Concern:

As your Broward County Property Appraiser, I am excited to write you this letter informing you of some very exciting news. As you know, a full ad valorem tax exemption is now available to Florida first responders who became totally and permanently disabled due to an injury sustained in the line of duty. Under the law, recipients of this exemption are required to renew their exemption every year unless a request is made by the Property Appraiser to the County Commission to pass a resolution allowing for an automatic renewal of the exemption. I recently approached the Broward County Commission about eliminating the need for the annual renewal. Commissioner Mark Bogen gladly agreed to sponsor this item and was joined by all of his fellow Broward County Commissioners Beam Furr, Steve Geller, Dale Holness, Chip LaMarca, Nan Rich, Tim Ryan, Barbara Sharief and Michael Udine as co-sponsors of this request.

At the November 7, 2017 County Commission meeting, this item was added to the agenda and unanimously passed. As of November 7, 2017, anyone who qualifies for the Full Exemption for Totally and Permanently Disabled First Responders will no longer be required to renew annually for this exemption.

FIRST RESPONDER DISABILITY EXEMPTION ELIGIBILITY REQUIREMENTS AND APPLICATION PROCESS

Any homesteaded property owner who is totally and permanently disabled as a result of injuries sustained in the line of duty while serving as a first responder with a Florida agency, or their un-remarried surviving spouse, is eligible for a full exemption on the ad valorem portion of their property taxes.

To apply, the First Responder, or surviving spouse, must submit the following documentation to the Property Appraiser no later than **September 18** of the year for which they are applying:

For applicants who have received a medical status determination of total and permanent disability from the Social

Security Administration must submit the following:	
	Documentation from the Social Security Administration stating applicant is totally and permanently disabled; and
	First Responder's Physician Certificate of Total and Permanent Disability (form available from Property Appraiser's Office); and
	First Responder's Employer Certificate of Total and Permanent Disability (form available from Property Appraiser's Office); and
	Employer's incident report or accident report documenting the event with caused the injury; and
	Documentation from the Social Security Administration stating applicant is <u>not</u> eligible to receive medical status determination from the Social Security Administration stating applicant is <u>not</u> eligible to receive medical status determination from the SSA and
	Documentation from the Social Security Administration stating applicant is <u>not</u> eligible to receive medical status determination from the SSA; and
	First Responder's Physician Certificate of Total and Permanent Disability (form available from Property Appraiser's Office); and
	2 nd First Responder's Physician Certificate of Total and Permanent Disability (form available from Property Appraiser's Office); <i>and</i>
	First Responder's Employer Certificate of Total and Permanent Disability (form available from Property Appraiser's Office); and
	Employer's incident report or accident report documenting the event with caused the injury; and

We are currently accepting pre-filed Disabled First Responder Exemption applications for tax year 2018.
