The Board of Trustees met on October 28, 2016, and among other items considered the following issues in the city ordinance and the DROP Rules were discussed:

- Abide by the language in the ordinance: 33.128 A DROP plan is to be created and administered by the Board of Trustees of the Police Officer's Retirement System at no cost and with no liability to the city.
- FRR/VRR* option during active employment only (up to 360 months of active service).
- VRR* Only Post Employment.

The DROP Rules state in part:

7.1 Amendment of DROP The Board reserved the ignAr InFinD and for time 1 t8e, an 2 root to by if deemed necessary or appropriate, to amend in whole or in part any or all of the provisions of the DROP. However, except as otherwise provided by law, no amendment shall make it possible for any part of the DROP's funds to be used for, or diverted to, purposes other than for the exclusive benefit of persons entitled to benefits under the DROP. No an the shall be rade with the trade with the trade of the DROP Account of any Police Officer.
